	Tuition is charged on a MONTH TO MONTH basis. Not by classes attended. There is a TWO MONTH minimum for all students. At ISDA
	your account is charged the same amount every month whether your dancer receives 3, 4 or 5 lessons. Students are strongly
	encouraged to attend appropriate make-up classes for those missed; there are never reduced or prorated monthly fees or refunds for
	missed classes. Make-up classes are to be taken within 30 DAYS of missed classes. Make-up classes MAY NOT be stockpiled or used
	at an time beyond the 30 DAYS out date. See studio staff for suggested appropriate make-up classes for your dancer.
	One full month's tuition, \$25 per family Registration Fee (due every new season) and class attire fees are due at the time of
	registration. Visa, Mastercard, Debit Card, Check or cash are acceptable only for these up front fees.
	Tuition is payable via 'Autopay' system only, an automatic monthly debit from your chosen debit/credit card account, on the
	5th of every month. Only ONE payment card will be permitted on any given student's account. If there is more than one 'paying' personal payment card will be permitted on any given student's account.
	those payments need to be arranged between those parties. ISDA will only accept ONE responsible party's payment method.

	There are NO month to month, 'pay at the studio' or 'pay by mail' tuition programs.
	A 3% ATM fee will be charged for all credit/debit card transactions made at the studio. Transactions done over the
	phone will incur a 5% fee. Monthly AutoPay tuition payments incur NO additional fees for monthly tuition charges.
	Any other charges to that account (clothing, shoes, performance fees, etc.) will incur a 3% fee.
	Any other charges to that account (clothing, shoes, performance rees, etc.) will fricul a 3% ree.
	In 2024-2025, ISDA will adhere to a strict dress code. We have arranged a Discount Program with one of our dancewear affiliates,
	and all dancewear will be purchased through them at much better prices than listed retail. Please check with staff to see what your
	dancer will require based on their enrollment.
	Due to constant COVID-19 changes that may occur, or any other major health outbreaks or concerns,
	dancers and families will always adhere to studio policies regarding any community or public restrictions.

	ISDA reserves the right to have students, who come late to class, to sit out. Repeated tardiness may result intermination of lessons.
	A minimum attendance standard is required. If a student misses more than 4 classes
	during any 3 month period of time, they will not be permitted to participate in our annual performances.
	ISDA is not responsible for providing before or after class care for students. Parents with students under
	the age of six must remain at ISDA during class. Students are not to be left at the studio for excessive time
	periods before or after classes.

	ISDA will hold parents or guardians of students liable for any damages incurred on studio property, or to

	Drinks are ONLY permitted in studio, inside sealed screw on drink containers. Pop on top or open top cups are NOT permitted.
	Devote local quardians of minors students and adult students waite the right to any local action for any injury
	Parents, legal guardians of minors, students and adult students waive the right to any legal action for any injury
	sustained on studio property resulting from normal dance activity or any other activity conducted by the student,
	parent or guardian, before, during or after class time. Including performances at non-ISDA venues.
	There is a two month minimum for all lessons. One month written notice from the 1st through the 7th of the prior
	month is required to discontinue any classes and avoid further charges to your AutoPay account. Withdrawal must be done in
	person and will not be accepted over the phone or by email. Withdrawal must be done at the studio reception desk with staff
	and not with the instructor. Withdrawal must occur within the first 7 days of the month to avoid further tuition charges the
	following month. A completed and signed Withdrawal Form is required. Home School/Charter students are also required to
	abide these rules and procedures. End of 'SEASON,' June 30, 2025 does not end AutoPay account obligation.
	30 Days Written notice is still required to discontinue monthly tuition comittment.
	ISDA reserves the right to terminate lessons of any students without notice.
